Chief Anchor informed the Board that the new truck chassis is ready. Mary will transfer funds for payment.

Treasurer Tinker presented her report and informed the Board that property tax payments continue to arrive daily.

Clerk Thompson prepared and handed out informational financial reports.

The ZBA at its December 2013 meeting approved the applicants request based on the revised drawings.

Glen Thomsen presented the Construction Manager Contract from the library project to use as a draft for the board to review on the bank building remodel. Mr. Thomsen recommends getting a site plan and survey showing the building, boundaries, parking, etc. and will check into the pricing on this. The zoning administrator will be contacted to determine if a zoning variance will be required. Mr. Thomsen was informed that there was \$128 thousand budgeted for the remodel and based on this figure, the areas of importance should be defined.

Attorney DuBay informed the board that a judgment has been presented for the illegal burn, and a default judgment has been entered by the court.

Also, in reference to the Reynolds Lake Fire Lane issue, a complaint will be filed on January 10, 2014 by Attorney DuBay.

Members of the Christie Lake Association are petitioning for a special assessment to lakefront property owners for the treatment of Eurasian water milfoil in their lake. Attorney DuBay stated that the Township Board could handle this matter or the Township Board can establish a "Lake Board" to consist of the drain commissioner, county commissioner, a lake association member, and a Lawrence Township board member to manage the process. The Board requested to be provided with a letter from the Christie Lake Association stating the intentions of the property owners via the association. The matter will be tabled until the February 2014 township board meeting.
