Rick Boze, representing the VB Co. Sheriff's Department announced that the public may access Smart 911 and the Citizenship Academy sign up at the VB Co. Sheriff's Department website.

Rick Boze representing the VB Co. Road Commission reported that the normal snowplow hours for the Road Commission are 7:30 a.m. to 3:30 p.m. Monday thru Friday.

Commissioner Hanson reported that the courthouse parking lot has gained 24 additional parking spaces from the demolition of the old house across the street to the south of the courthouse. The VB County drug court reports an 80% graduation rate which is one of the highest in the state.

Chief Anchor reported that the Eau Claire Fire Department has made an offer of \$35,000 for the Pumper/Tanker and suggested that the board accept the offer, with delivery to take place sometime in March 2015.

A motion was made by Thompson and second by Reynnells to accept the offer from the Eau Clair Fire Department of \$35,000 for the purchase of the Pumper/Tanker, with a \$5000 non-refundable deposit. The balance due will be payable upon delivery.

Roll Call Vote: All ayes. Motion carried.

Chief Anchor explained the newly adopted minimum attendance requirement of the LTES which will become effective in January 2015.

LTES has received an \$1800 DNR grant (which is a 50/50 matching grant), which is to be used for the purchase of a foam unit, fire swatters and brooms. All paperwork and supporting documentation must be submitted by 9/8/2015.

Chief Anchor also informed the board that a FEMA Grant has been applied for . The award is expected to be announced in March 2015. Our share of the grant would be 5%. LTES would plan to use the grant to purchase 20 air packs, 20 spare tanks and a breathing air compressor.

Treasurer Tinker believed that the BS&A training that she and the deputy treasurer attended was very beneficial. The treasurer will need to know how soon the chief will need monies available for payment of the new truck.

There was no report from the ZBA.

Clerk Thompson reported on the recent re-count for Hartford School board proposal.

The Planning Commission has a meeting scheduled for next week.

Anita Thomas, the VB Co. Senior Services Representative for Lawrence Township, would like to step down from those duties and asked the Board to be seeking her replacement.

Glen Thomsen gave an update on the bank building progress. He has been reviewing the preliminary plans in an effort to resolve as many issues as possible before they are finalized.

Steven Bryer of Siegfried Crandall, PC presented a very positive township audit report.

Representatives from Baron Land Corporation presented information on several parcels that they wish to split. After much discussion, a special board meeting was scheduled for Monday, December 29, 2014 at 7:00 p.m.to allow for further discussion and possible approval of the splits.

Supervisor Barnett will present his proposal for new inspectors at the January 2015 board meeting.

With no further business to attend to, a motion to adjourn the meeting was made by Reynnells and second by Stroud. All ayes, motion carried.
