There was no report from the Van Buren County Sheriff's Department.

Rick Boze representing the VB Co. Road Commission informed the Board that the plows operate during the hours of 7:00 am to 3:30 pm during the week. On the weekends, primary roads are plowed with 4 or more inches on snow and county and local roads are plowed with 8 or more inches.

Commissioner Hanson presented highlights of the year-end report for the county. He reported that the state wants 17 year olds to be processed as juveniles for all crimes, which will cost the county approximately 250 thousand a year.

The Health Department (Jeff Elliott) is looking into building a new office in the Lawrence-Crandall Industrial Park.

Chief Anchor reported that LTES was turned down for the DNR Grant to equip fire fighters with LED flashlights. We will try again next year.

Several area departments will submit a regional FEMA Grant Application Request for air packs and spare air cylinders. It is hoped that a regional request will increase our chances of being funded.

We received a quote from Thomsen Construction for the stairway frame in project in Ken and Scott's office.

A motion was made by Reynnells and second by Tinker to approve the stairway enclosure project as presented, at a cost of \$3592.00. Roll call vote. All ayes. Motion carried.

Treasurer Tinker gave the November financial report. She also stated that ECCU will no longer insure funds in excess of \$250,000. She needs to find a new bank in which to place the overage.

A motion was made by Thompson and second by Tinker to add PNC Bank as an approved bank for investments. All ayes. Motion carried.

A motion was made by Tinker and second by Reynnells to remove the previous Deputy Treasurer, Theresa Carr from all bank accounts and add the new Deputy Treasurer, Theresa Stroud. All ayes. Motion carried.

Clerk Thompson reported that the W-2 forms have been sent out to all township employees.

Kim will be attending the MTA Conference next week.

The House and Senate passed election legislation that states that we can no longer provide information on proposals further out than 60 days before an election.

Current financial statements were distributed to the board.

There was no report from the ZBA.

The Planning Commission had no report as it did not meet in December.

Under old business, Attorney DuBay told the Board that Mr. Sewel is claiming a disability in the blight case.

A "For Sale" sign will be placed in the bank building. The Board agreed on an asking price of \$75,000. Interested persons should submit an offer in writing, or come before the Board with offers to be considered.

The Treasurer and Deputy Treasurer suggested that the Board consider new office space for them which would provide more space and privacy for the public when taking tax payments.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Tinker. All ayes. Motion carried.
