Rick Boze from the Van Buren County Sheriff's Department informed the Board of a new storm watcher class that the Department is sponsoring. Interested persons should contact the VB Co. Sheriff's Department for more information. He also reported on the IRS phone scam.

Rick Boze representing the VB Co. Road Commission informed the Board that the CR 681 project will be completed this year. Tree cutting will begin soon. Also discussed was the 51st Street drain. Mr. Boze suggested that the Township may want to consider starting a contingency fund to save for future drain projects due to several aging drains.

Lawrence Village Manager, Dan Faulkner informed the Board that water/sewer rates will be increasing by 18% to pay for the upcoming wastewater project. The project will begin sometime mid-summer to fall. The water tower refurbishing project will be completed by late summer 2016.

The Health Department will build their new office building on ISD property.

The Village has applied for MDOT Road Taskforce grant money for a 3 inch overlay on West St Joseph Street from the main four to Michigan Street. The project is scheduled for some time in 2018.

Flags have been donated for the Village.

Chief Anchor reported that the keyless entry system for the fire station will be installed by Tyco around the first week of March 2016. Each employee will be provided with a key fob, card, cell phone sticker and an individual touchpad code for entry. Scott is gathering equipment quotes for the video system which he will install.

The new #1710 QR Truck is due to be completed early in March.

Chief Anchor returns to the doctor on February 24, 2016 and hopes to be able to return to work after that with no restrictions.

In a motion made by Reynnells and second by Stroud, Budget Meetings have been scheduled for March 5 and March 12, 2016 from 9:00 a.m. to 12:00 noon. The Annual Meeting has been scheduled for March 26, 2016 at 1:00 p.m. All ayes. Motion carried.

There are two insurance proposals for the new fiscal year. One will be heard at the March 5 budget meeting and Jason Orton of David Chapman Agency will present their proposal during the March 10 regular board meeting.

Commissioner Hanson reported that District Court is having a hearing on Public Act 269. The county is considering a 2nd set of servers or a merit line for data backup. The Sheriff Department's K-9 officer, Goliath passed away. Blitz will be his replacement at a cost of \$6500.00. The K-9 unit currently has two dogs.

Beth Griffin, who is an Antwerp Township Commissioner, is running for State Representative replacing Aric Nesbit. She introduced herself to the Board and gave some background history.

Treasurer Tinker gave the financial report.

Treasurer Tinker made a motion to add Edgewater Bank to the list of approved banks for the Township. Motion was second by Reynnells. All ayes. Motion carried.

In Clerk Thompson's absence, Deputy Clerk Hardin highlighted the areas of interest on the financial statements which involved the Elections cost center and the Building Department cost center.

A motion was made <u>myby</u> Tinker and second by Stroud to revise the budgeted total for the elections expense account under the General Fund to a new total of \$4000.00 to allow for March 8th election expenses. Roll call vote. All ayes. Motion carried.

A motion was made by Stroud and second by Reynnells to revise the budgeted total for the building expense account of the Building Department Fund to a new total of \$15,000.00 to account for February and March 2016 activity. Roll Call Vote. All ayes. Motion carried.

While at the MTA Conference, Clerk Thompson met a representative from an architectural firm who had worked with a township to remodel a donated bank building into township offices. The firm has an in depth knowledge of the codes and is willing to give our project a review and second opinion for a fee. The Board would like Clerk Thompson to contact the township involved and get the specifics on their project before they would be willing to spend any additional amounts on the bank building.

There was no report from the ZBA.

The Planning Commission had no report due to lack of quorum at its last meeting.

There was a brief discussion on the funding for the culvert on 51st Street. It was decided to table this topic until the upcoming budget meeting.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Stroud. All ayes. Motion carried.
