Rick Boze from the Van Buren County Sheriff's Department informed the Board of a new report format. He reported that there were 98 total calls in February 2016.

Rick Boze representing the VB Co. Road Commission informed the Board that the 51st Street drain project is pending the Board's approval. Pot holes are being filled and residents are urged to contact the Road Commission to report the location of those holes needing attention.

Lawrence Village Manager, Dan Faulkner informed the Board that water/sewer rates will be increasing by \$5.59 per unit. The sewer project is still out for bid.

The Health Department and the ISD met with the Village to discuss some zoning issues in regard to the new Health Department office building.

Park improvements are underway.

Chief Anchor and the Board would like to return to the previous call report format. The Chief will inquire as to the possibility of that request.

We should have the new 1710 by next week. Also next week the keyless entry system is scheduled to be installed.

The Chief reminded the Board of the annual dinner which will be held at La Cantina on Saturday, May 21, 2016. Invitations will go out in April.

Mr. Jason Orton of David Chapman Agency presented the Board with the insurance renewal quote. PAR Plan is still the best option for coverage and price.

Commissioner Hanson reported that the new Health Department building in Lawrence will also be the location for the Van Buren/Cass County Dental Clinic and will bring approximately 50 employees into the area. The ISD plans to start a dental assistant program in partnership with the Health Department.

Commissioner Hanson introduced Mike McKay who is running for Van Buren County, District Court Judge. Mr. McKay introduced himself and gave some background information.

Mr. Barron Page of Southwest Michigan Dust Control in Bloomingdale gave a presentation and requested Lawrence Townships' business.

Marie and Roy Westendorff Jr. submitted an offer on the bank building to the Board. The offer consisted of \$59,999 for a land contract at 8% interest with a 10 year balloon. Payments based on a 30 year fixed rate and a \$12,000 down payment. A special meeting will be scheduled to discuss the offer.

Treasurer Tinker gave the financial report.

Clerk Thompson reported the local results of the recent Presidential Primary.

The neighbors of 50101 50th Street voiced their concerns over a continuing ordinance violation of high intensity lighting for which the responsible property owner has been notified in writing of the violation. Attorney DuBay will file a formal complaint with the judge.

In regard to the continuing Sewell blight issue, Attorney DuBay will petition the court for relief.
