✓ County Commissioner

Rick Boze from the Van Buren County Sheriff's Department informed the Board that there were 110 total calls in May 2016.

Rick Boze representing the VB Co. Road Commission informed the Board that the CR 681 Project should be completed by the end of July. The Keeler <u>CR</u> 687 Project is getting underway. The bid on the tube has been approved. Calcium Chloride is coming soon. Road grading must be completed first. Mr. Boze presented the Board with a flyer on the proposed road millage.

Commissioner Don Hanson reported that the County currently has a digital back up system with 20 year old technology. They are looking into updating their system. The recent jail inspection confirmed the privacy issue with the booking area. They are estimating \$5 million for complete renovations.

There was no report from the Village of Lawrence.

Chief Anchor informed the Board that the annual physicals are scheduled for June 18, 2016.

The Chief presented the resignation of Ken Barnett from LTES. Per the recommendation of the LTES membership, a motion was made by Reynnells and 2nd by Tinker to accept Ken Barnett's resignation from LTES. All ayes. Motion carried.

The <u>4720_1726</u> Refurbishing Project is underway and the committee is currently accepting quotes and estimates.

A motion was made by Thompson and 2nd by Reynnells to adjust the probationary wage to \$8.50 per hour to meet minimum wage requirements. Roll call vote. All ayes. Motion carried.

Treasurer Tinker had no financial report due to lack of bank statements. She will report next month. She is still working on obtaining new check stock from Edgewater Bank for LTES account.

Clerk Thompson reported that she will be scheduling new election inspectors for training.

There was no report from the ZBA due to no new zoning applications.

The Planning Commission's next meeting is in July. A Resolution was presented approving the distribution of the Proposed Master Plan. Motion to approve Resolution was made by Reynnells, and second by Stroud. Roll call vote. All ayes. Resolution adopted.

Dan Abbott, candidate for Sheriff, introduced himself and spoke of his qualifications.

David Walker, candidate for Sheriff, introduced himself and presented his qualifications.

Attorney DuBay submitted a letter of resignation as Township Attorney effective, August 19, 2016. A motion was made by Reynnells and 2nd by Stroud to accept Attorney DuBay's resignation. All ayes. Motion carried. The Board thanked Attorney DuBay for his 19 years of legal counsel to the Board and the citizens of Lawrence Township.

A motion was made by Thompson and 2nd by Reynnells to accept the resignation of Supervisor Ken Barnett which was presented at the May 2016 Board Meeting, to be effective June 23, 2016. All ayes. Motion carried. The Board thanked Mr. Barnett for his service to the community on the Board and with the LTES.

WHEREAS, MCL 125.3843(3) gives the Township Board the right to approve or reject the Master Plan after the Planning Commission's public hearing so long as it retains this right by resolution:

NOW. THEREFORE. BE IT HEREBY RESOLVED. that the Lawrence Township Board of Trustees does approve the distribution of the proposed amendment of the Muster Plan to those entitled to review and comment, service of the plan may be made electronically putsuant to MCL 125.3839(3) by providing a link to the Township website.

BE IT FURTHER RESOLVED, that the Lawrence Township Board of Trustees bereby retains the right to approve or reject the proposed amendment or any changes that may be made after this date as a condition of the amendment becoming final.
