Rick Boze from the Van Buren County Sheriff's Department informed the Board that there were 116 total calls in July 2016. Updates to the Smart 911 System were discussed.

Rick Boze representing the VB Co. Road Commission updated the Board on the status of CR 681 and 54th Street. Political signage in the right of way will be removed. The annual Snow Plow Rodeo will be held on Thursday, August 25, 2016. Resident concerns over the number of accidents occurring at Red Arrow Highway and CR 681 should be directed to Larry at the Road Commission.

Dan Faulkner with the Village of Lawrence told the Board that Ox Roast preparations are underway and volunteers are needed. The issues of un-mowed lots in the Village are being addressed. The liquor license for Jaco's is in process. Due to insurance liability issues, organizations will no longer be allowed to take up donations in the roadway at the main four as has previously been allowed.

Chief Anchor informed the Board that all but one member has completed fit testing and that testing is scheduled for September. Shawn Mead will be taking medical classes this fall for EMT Certification. Active Shooter classes are being offered this fall and MABAS training will be held in October. The refirb project for 1726 is underway.

The Chief gave a reminder of the LTES Family Picnic to be held on August 13th.

Treasurer Tinker submitted the financial report for July. The LTES checking account will be transferred back to Mercantile Bank prior to the next billing cycle.

Clerk Thompson reported that there were 597 votes tallied for the August primary election, with 66 absentee ballots. The Clerk has sent several absentee ballot request letters to voters in our jurisdiction who have reached the age of 65. The response has been good and she will resume sending them in anticipation of the upcoming general election.

Karen Hardin is the new election chairperson. She chaired the Primary and will chair for the second time for the general election in November.
