Rick Boze from the Van Buren County Sheriff's Department informed the Board that there were 116 total calls in October 2016.

Rick Boze representing the VB Co. Road Commission reported that they are currently working on grading and tree cutting. The 60th Avenue turn around issue was discussed and Supervisor Spenner will be in contact with the road commission on this issue. Clerk Thompson requested an updated certified road map.

Commissioner Hanson reported that stricter controls and policies are being studied for the VBCO employees, en light of the recent incident at the Berrien County Courthouse where two deputies were killed. A 32 mil proposal will be on the May 2nd ballot to fund a project to expand the courtrooms, build a new jail with a tunnel to transport inmates to trial. Union negations are in process.

Chief Anchor informed the Board that the pump tests have been completed and successful.

William Gaborick was recommended by the membership to probationary status with the fire department.

A motion was made by Reynnells and supported by Stroud to approve William Gaborick for 6months probationary status with the fired department pending the results of his physical and drug screen. All ayes. Motion carried.

LTES along with a few other departments will be applying for the FEMA Grant again this year. If successful in obtaining the grant, the money will be used to purchase air tanks.

Treasurer Tinker submitted the financial report for October 2016.

Steve Bryer of Siegfried Crandall presented the audit report to the Board. He stated that the township was in a solid financial position and he offered a clean audit opinion.

Clerk Thompson commented on the recent election and thanked everyone involved for a job well done

The ZBA had no report, due to no new applications.

The Planning Commission has received the corrected site plan. There will be a special use permit hearing for McDonald Towing.

Old Business on the Agenda will be postponed as the Clerk is still waiting for additional information from the O'Connell Group, and references for review. This item will be tabled until the January 2017 meeting for voting.

Under new business, the Board appointed Clerk Thompson to the DDA and the LDFA, instead of Trustee Reynnells as was indicated at last month's meeting. Trustee Reynnells will be the townships' representative to the Road Commission.

Public Comment: Question on the township police patrol from the Sheriff's Department.

Attorney Heckman presented the board with a summary of the outstanding legal issues.

The Sewell blight clean-up is scheduled for November 27, 2016.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Stroud.
