There was no report from the VB Co. Road Commission.

Commissioner Hanson reported that Union negations negotiations continue. The Palisades Nuclear Plant closing in 2018 will result in a one million dollar loss of tax revenue for the county.

Lawrence Village Manager Dan Faulkner reported that the Village was looking to hire a Crossing Guard. The Health Department is still reviewing plans for their new building as the placement of current power lines has forced them to reduce the square footage of the proposed building.

The joint meeting of the Village and Township is scheduled for January 24, 2017 at 7:00 p.m. Topics of the agenda are: Two Rivers Coalition

Joint Park and Recreation Committee Ox Roast, Easter Egg Hunt and X-Mas in the Village Industrial Park Insurance Concerns

Mary Muday presented the event line up for this year's Christmas in the Part Park event.

Chief Anchor informed the Board that Mike Beach has met the criteria for regular membership for the fire department and recommended that the Board accept his membership.

A motion was made by Reynnells and supported by Stroud to approve Mike Beach for regular membership on the Fire Department. All ayes. Motion carried.

Truck maintenance continues.

Scott Earls asked the Board to approve an additional part time worker (4 to 5 hours per week) for the cemetery and building maintenance. The Van Buren County Community Health Department has recommended Chris Carpp who also works for the Village of few days per week.

A motion was made by Reynnells and supported by Stroud to authorize an additional part time worker to be paid from the already budgeted part time sexton account, providing that the work is within his capabilities.

All ayes. Motion carried.

Treasurer Tinker submitted the financial report for November 2016. She questioned the \$29,374.39 IRS automatic withdrawal from Mercantile Bank. Clerk will need to address this with the Treasurer upon her return from vacation.

There was no Clerk's report. Deputy Clerk Hardin presented the Board with the financial statements.

The ZBA had no report, due to no new applications.

The Planning Commission has received the corrected site plan for the McDonald Towing project. A motion by Reynnells and second by Stroud that the approval of a special use permit for McDonald's Towing (AKA Schoolcraft Holdings LLC), is adjourned to a time to be determined in order to allow for document submission by AGS and/or other parties for review. All ayes. Motion carried.

There was no Old Business on the Agenda.

Under new business, Clerk Thompson will conduct the Oath of Office the week of December 12, 2016.

Public Comment: Mr. Ron Moffit had a house fire at 68241 52nd Street on January 20, 2010. He claims that the property has been cleaned up but the Township is still holding \$3800.00 of his insurance funds from this fire. Treasurer Tinker stated that she has not received the permission to release these funds. Chief Anchor will look into this issue.
