Rick Boze, reporting for the Van Buren County Sheriff's Department reported that there were a total of 50 incidents for the month of March.

Rick Boze representing the VB Co. Road Commission informed the Board that the Road Commission's attorney has contacted Mr. McDonald via letter in regard to the driveway permit issue. Supervisor Spenner requested a meeting with Mr. Boze to further discuss the McDonald Towing issue as well as communication standards between the Township and VBRC.

Commissioner Hanson reported that the County Administrator has resigned. Fourteen applications have been collected for his replacement. The applications are being reviewed and the top five contenders will be interviewed on May 5<sup>th</sup> at 1:00 p.m.

The 5.3 million jail renovation project has begun. Large fuel tanks are being removed to allow for the expansion.

Judge Kathleen Bickley updated the Board with the State of the Court Address. She also explained how the upcoming millage proposal if passed, would greatly enhance public and employee safety at the courthouse.

Chief Anchor reported that the bidding process for the lighting project is complete. Based on specific criteria, Midway Electric is the recommendation from LTES. Clerk Thompson presented information on the Small Business Energy Efficiency Program via Consumers Energy that she obtained at the recent MTA Conference. A brief discussion ensued. Recommendations will be tabled while additional information is sought on the small business program.

Treasurer Tinker gave the financial report for March 2017.

Mr. Jason Orton of the David Chapman Insurance Agency gave an update on rates and coverages. This is the second year of our three year term agreement.

Par Plan has grant money available. Applications are due next month. Some organizations are using the grant money for new striping on fire and rescue vehicles. This would require a resolution at next month's meeting.

Jason would like to meet with the LTES membership this summer/fall to update information for the Accident and Health Policy.

Clerk Thompson reported that the new budget figures are not in the system yet. April and May financial statements will be in next month packets.

The May 2<sup>nd</sup> election will include a single proposal to vote on a proposed millage to improve public safety and public services with an increase of 0.70 mills. The public accuracy test will be done on April 26<sup>th</sup>.

Clerk Thompson made a motion to accept the purchase offer of \$30,000.00 for the sale of the bank building which was made at the annual meeting. The building is offered as is/where is with a non-refundable down payment of \$500.00. Tinker second the motion. Roll call vote. All ayes. Motion carried.

Attorney Heckman will draft a purchase agreement to be signed by all parties.

There will be a ZBA meeting on May 8th, 2017 at 7:30 p.m. to review a variance request.

The Planning Commission had no report.

A motion was made by Thompson and 2<sup>nd</sup> by Tinker to approve a Resolution of Appreciation to Denise Campagna, upon her retirement. The Board expressed their appreciation for her years of service to the community as the Lawrence Librarian. Roll call vote. All ayes. Resolution approved.

A motion to approve the Household Chemical Waste Program for 2017 was made by Reynnells, and 2<sup>nd</sup> by Spenner. Roll call vote. All ayes. Motion carried.

Spenner, Thompson and Stroud discussed various aspects of the MTA Conference which they recently attended.
