Rick Boze, reporting for the Van Buren County Sheriff's Department reported that there were a total of 25 incidents for the month of April.

Rick Boze representing the VB Co. Road Commission informed the Board that the CR 687 project will begin in June 2017, CR 681 and Red Arrow Highway has been delayed until next year. <u>Clerk Thompson</u> commended the Road Commission of the gravel application, stating good quality and a great job.

Commissioner Hanson reported that Palisades is refueling even though they are scheduled to close. Five applicants have been interviewed for the County Administrator position and a recommendation has been made. The millage vote failed so the county is looking into financing from the Dept of Ag for the new Health Department building.

Chief Anchor summarized the bids and rebate programs for the Fire Department lighting project. A discussion ensued resulting in the following motion.

Motion by Reynnells, second by Spenner to accept the bid submitted by Midway Electric, Inc. as presented at the last board meeting. Roll call vote: Stroud – aye; Reynnells – aye; Thompson – aye; Spenner – aye; Tinker – abstain. Four members – yes, one abstain. Motion carried. Clerk Thompson will have Consumer's Energy validate both rebates.

Chief Anchor presented the Board with the Resolution to participate in the "Michigan Participating Plan Risk Reduction Grant Program", which will provide grant funds to provide chevron striping to the water rescue trailer.

A motion was made by Thompson and second by Tinker to approve the grant program resolution as presented. All ayes. Motion carried. (See attachment 1.)

Chief Anchor recommended William Gaborik be accepted to regular membership of the LTES as he has completed his probationary period and the membership has voted in support of this recommendation. Motion by Reynnells, second by Tinker to accept William Gaborik as a full time member of the fire department as recommended. All ayes. Motion carried.

Chief Anchor reminded the Board of the upcoming LTES Awards Banquet on May 20, 20017.

Treasurer Tinker gave the revised financial report for March 2017 as well as the report for April.

Clerk Thompson reported on the May 2<sup>nd</sup> election and presented the April financial statements.

Clerk Thompson explained the need for codification of our ordinances and made a motion to approve the General Code proposal for codification in the amount of \$6335.00. <u>Motion second by Spenner</u>. Roll call vote. All ayes. Motion carried.

There was a ZBA hearing on May 8<sup>th</sup> for a setback variance. The request was denied. Dick Reynnells, who has served on the ZBA since its formation, has resigned. Supervisor Spenner will contact potential replacements.

The Planning Commission is meeting monthly to revise the Master Plan to allow for wineries, cider mills, etc. as special use in the Ag zone.

Trustee Stroud informed the Board of the Michigan Association of Planning (MAP), which she learned about at the MTA Conference. The organization offers resources and educational opportunities to its members and will hold regional and on site workshops as well.

A motion was made by Stroud and second by Tinker to join the Michigan Association of Planning at a cost of \$650.00 annually. Roll call vote. All ayes. Motion carried.

Under Old Business, Attorney Heckman e-mailed a 30 and a 60 day purchase order to Clerk Thompson for the purchasers' signature. The Township must still continue to entertain offers until the official closing.

Supervisor Spenner lead a discussion on resurrecting the Parks and Recreation Committee.

The Village will be getting a new patrol officer from the Sheriff's Office as Adam Bielang will be leaving for a new position.

There was no public comment.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Stroud. All ayes. Motion carried.
