Rick Boze, reporting for the Van Buren County Sheriff's Department stated that there were a total of 48 incidents for the month of May.

Rick Boze representing the VB Co. Road Commission reported that seal coating has begun. Grading and dust control measures have also begun. Trucks are being used for the grading process as the graders are tied up with the seal coat process. If residents feel that grading has not been done properly, they should contact the road commission.

Regarding the dry chloride dust treatment available to residents on dirt roads, the two bags of chloride per "household" is a Road Commission policy. Mr. Dan Sobek who resides on Howard Drive and owns several parcels requested that the policy be changed to reflect the number of bags allowed to parcels owned and not just the parcel that a home sets on.

Commissioner Hanson reported that the county has applied for a \$267K grant for the work release program. The state has given the county 180 days to devise a plan for the administration of assigning public defenders for indigent persons. The county is working with another county and is hoping to be able to combine their efforts.

Dan Falkner, Lawrence Village Administrator reported that the ZBA approved the Lawrence Downs project, and construction will begin in October. The Freedom Bar & Grill is getting closer to opening. They are currently working with the health department for approval of equipment and systems. The CMAQ and the Safe Routes to School Trail are both looking into grants for project funding. The Shack will hold an open house on June 14th. Everyone is encouraged to attend and support local business. The next joint Village/Township meeting is scheduled for July 25th.

Chief Anchor informed the Board that the Electric Project is moving forward as scheduled. Midway Electric is now certified for the Consumer's Small Business Program. Mary Tinker stated that our estimated incentive is \$2173.00.

Treasurer Tinker informed the Board that due to lack of bank statements that she was not able to compile a financial report.

Clerk Thompson presented the May financial statements. Information was presented on the new voting system with pricing and grant information.

Motion by Thompson and seconded by Tinker to adopt the Resolution for Michigan Secretary of State grant funding for election equipment as presented. Roll call vote. All aye. Motion carried. (See Attachment 1)

Motion by Thompson and seconded by Tinker to purchase a 2nd back up tabulator at a cost of \$4337.00. Roll call vote. All aye. Motion carried.

There was a ZBA hearing on May 8th for a setback variance which was denied. The property owners are trying to acquire additional property to resolve the zoning violation.

The Planning Commission is meeting on June 27th.

Under Old Business, Lance Goodrow Goodrode is still interested in purchasing the bank building according to a conversation he had with Clerk Thompson, but he has not signed the purchase agreement so we will continue to entertain offers.

Clerk Thompson informed the Board that Anita Ghastin and Donna Neyome-Ghastin have submitted their resignation(s) effective September 1, 2017. Anita has served as the township's assessor since 1990. She did offer a few recommendations for replacements.

A motion to regrettably accept the resignation of Anita Ghastin and Donna Neyome-Ghastin was made by Spenner and supported by Thompson. All ayes. Motion carried.

The date for the Truth in Taxation hearing will be set at the August meeting.

The new FOIA policy as well as procedures and forms were presented.

A motion by Thompson to accept the FOIA policy, procedures and forms as presented was supported by Spenner. All ayes. Motion carried. (See Attachment 2)

There was no public comment.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Stroud. All ayes. Motion carried.
