Rick Boze, reporting for the Van Buren County Sheriff's Department, stated that there were 66 calls for the month of October 2017. Applications are still being accepted for the next Citizens Academy beginning January 17, 2018.

Rick Boze, representing the VB Co. Road Commission, reported that they are currently working on trees and gravel roads until the snow flies. There have been 23 requests for service from Lawrence Township with 18 being resolved.

Chief Anchor told the Board that the ISO Inspection went very well. They were impressed with how well prepared we were for them. The Michigan rebate for the electrical project will be \$2173.10. Mike will begin researching grants to allow us to obtain a new shocker for the QR team.

Treasurer Stroud gave an explanation of the Escrow Account. She stated that Deputy Treasurer Sheryl Moses is going to be a huge asset.

Clerk Thompson presented the October financial statements.

The ZBA has no applications to review so there is no meeting currently scheduled for December.

The Planning Commission will be reviewing a change in zoning request to allow special use for a barn to be used as a reception venue at their next meeting.

Commissioner Don Hanson reported that the 911 system can now accept text messages. Through a \$130,000 grant for the Community Correction Program, nonviolent offenders will be able to do public service projects on the weekends instead of being jailed. The Emergency Manager, Robert Kirk will be starting a new emergency situation program.

Under Old Business, Bill Hoffman representing the Reynolds Lake Association presented a special assessment draft petition for weed treatment on the lake. He stated that there are 109 parcels on the lake with an additional 20 parcels with lake access. Attorney Heckman advised him to have an attorney review the language on the petition before circulating the petition for signatures.

Under New Business, a special meeting is scheduled for November 20<sup>th</sup> at 7:00 p.m. to hold interviews to appoint someone for the vacant trustee position.

A resolution to set the Board of Review dates for the July meeting on the Wednesday following the third Monday in July and the December meeting is set for the Wednesday following the second Monday in December.

Lorraine Vale, who is seeking a special use permit for her reception venue introduced herself and asked if the Board had any questions for her.

Chief Anchor stated that he had a request to use the fire station on December 16, 2017 for the Holiday Community Festival.

Supervisor Spenner informed the Board that AGS has proposed changes to their service agreement. Donna will review and provide a comparison of the proposed changes for review and discussion.

The VB Co. Road Commission is planning projects for the 2018 construction season and is seeking input from the Board. This item will be placed on next month's agenda for discussion.

With no further business to attend to, a motion to adjourn was made by Reynnells and second by Stroud. All ayes. Motion carried.
