#### **Van Buren County Sheriff Department**

Deputy Todd Skinner of the VB Co. Sheriff's Department reported that there were 37 calls for the month of March 2019. Reported that Paw Paw Township approved their ORV ordinance. Reported he now serves 6 townships.

### **Van Buren County Road Commission**

Rick Boze reported that there were 31 service requests for the month of March, with 14 unresolved. Most of the unresolved related to grading requests for gravel roads. Frost restrictions are now lifted, and they will be grading and rolling for the next few months. There is now a moratorium on roadside tree cutting due to the bat protection laws.

#### **Van Buren County Board of Commissioners**

Commissioner Hanson reported that:

- the Equalization Department reported a 1.1% increase in SEV.
- The 911 budget has been presented. \$1.92 per device will generate \$1.3M and will finance the entire 911 system.
- Reported that changes have been made to the Public Defender system. Each county now has one public defender. VBC has hired Chat Catlenoe as the PD with 2 part-time assistant defenders and 1 investigator.
- The Health Department building at the VBISD will go out for bid in May

### **LTES**

Chief Anchor is attending the FDIC fire convention. Captain Earls presented the report for March. 11 calls for fire service with 1 mutual aid to Hartford and 23 calls for service for quick response.

### Village of Lawrence

No report from the Village of Lawrence.

### **Treasurer**

Treasurer Stroud presented her monthly reports. The Special Assessment District for Reynolds Lake weed control will be on the summer tax bills. Reported on sessions she attended at the Michigan Township Association (MTA) conference. One related to fraud. She was happy to report that we have many internal controls in place to prevent fraud and embezzlement, unlike other townships who have

experienced significant issues and financial loss. She shared with other Townships the controls we have in place.

#### Clerk

Clerk Thompson presented the monthly financial statements.

Direct deposit of employee paychecks was discussed. Arbor will provide a direct deposit authorization form. Thompson will distribute to begin direct deposit in May or June.

### ZBA

Spenner nominated Bob Thomas, supported by Thompson to appoint Bob Thomas as a ZBA member to fill the vacancy of Mark DuBay. Thomas is a former ZBA member and we welcome him back. All aye. Motion carried.

#### **Planning Commission**

Carpp presented information regarding the status of the Village of Lawrence medical marihuana ordinance. Stated the Lawrence Township Planning Commission (PC) would like the board to formally recommend whether or not to work on a Township medical marihuana ordinance. All the board members in attendance responded with Yes. Carpp will notify the Township PC and they will work towards developing an ordinance. The next PC meeting will be April 23, 2019.

### **OLD BUSINESS**

### **New Town Hall Update**

Bids have been received and the bids were significantly higher than anticipated. Discussion was held on how to reduce the scope to keep in line with our budget. All agreed that the building addition for the covered ramp system can be a Phase 2 project. This phase will simply include the ramp. Also discussed changing to shingled roof vs. metal. Metal roof can also be a Phase 2 project. Open to other suggestions and discussion with the bidders at the April 18 special meeting.

### **Building and Zoning Enforcement**

Safe Built will present information regarding their services along with a quote and will attend the May meeting.

#### **NEW BUSINESS**

### **Audit**

The 2018/2019 fiscal year audit has been scheduled for July 1-3, 2019. Motion by Thompson, supported by Stroud to approve the Siegfield & Crandall agreement. Roll call. All aye. Motion carried.

#### **ORV Map Revision**

With the Paw Paw Township adoption of their ORV ordinance, Lawrence Township can amend our map to show that the Lawrence/Paw Paw Township boundary roads are open for ORV use. Motion by Spenner, supported by Carpp to approve the Resolution Amending the Lawrence Township ORV Map. Roll call. All aye. Motion carried. (Attachment 1)
